May 12, 1900 (1)

At a meeting of the Pension Board of Prince William County, Va. on the 26th day of April 1900, present J. S. Powell, W. W. Kincheloe, R. H. Tyler, Westwood Hutchison, and E. Nelson appointed by the Judge of Circuit Court of said county.

The Board organized by electing Dr. J. S. Powell, chairman, and E. Nelson clerk of the said board.

The said board appointed the 12th day of May 1900 to meet and pass upon such application as were filed before them and requested the clerk to give notice of said meeting and time.

On motion it was ordered that the Clerk be instructed to notify auditor that the list of pensioners as certified by him to this board be retained on said list except the names of G. W. Johnson and Mary A. Matthew

Merchant and Westwood Hutchison. On motion of Westwood Hutchison the act of this board on June 10th and June the 21st was rescinded.
